The meeting was called to order at 1:10 PM MST by Mary Jo White, DC.

APPROVAL OF MINUTES

Dr. Downey made a motion to approve the minutes of 11/20/2015. It was seconded by Dr. Oliver. Motion carried.

LEGISLATIVE REPORT

Ms. Cory gave the legislative report. She said that the Board's proposed rule has been heard and approved by the House and Senate Health & Welfare Committees. Ms. Cory said the Board's legislation was sent to print and the bill will be scheduled for a hearing in the Senate Health & Welfare Committee. She said the Bureau will let the Board know the date and time of the hearing.

Dr. White reviewed the information that was included in a packet to both the House and Senate House Health & Welfare Committees, along with the presentation of the rule by Mr. Hales.

FINANCIAL REPORT

Mr. Fitzgerald presented the IACP's revised proposed draft legislation to the Board. He said the IACP has discussed the proposed draft with legislators and received assistance in finishing the proposed draft. Mr. Fitzgerald said that Chairman Wood suggested a separate formulary subcommittee consisting of two chiropractors and a lay person appointed by this Board, a medical doctor appointed by the Idaho Board of Medicine, and a pharmacist appointed by the Idaho Board of Pharmacy. Dr. Oliver asked Mr. Fitzgerald if the proposed legislation would include clarification of informed consent. Mr. Fitzgerald said that it is possible to include language regarding informed consent in the IACP's proposed draft legislation, and he will bring the language back to the Board for its review.
