Mr. Thomas addressed the Board regarding a proposed law change requiring Idaho landscape architect college professors be licensed in order to teach landscape architecture. Mr. Hales advised the Board that it may want to review its current laws to see if this matter is within the Board's jurisdiction and if teaching landscape architecture is in fact practicing landscape architecture. The Board was concerned that this may be a public safety issue. Ms. Cory suggested that the Board invite Mr. Stegner, from the University of Idaho, to its next Board meeting for an informal discussion on the matter.
