LEGISLATIVE UPDATE

Dr. Warner reported that he and Ms. Calahan attended a meeting at the Idaho Medical Association office. The meeting was attended by representatives of the Idaho Medical Association, the Idaho Society of Ophthalmology, the Idaho Optometric Physicians, and the Idaho Board of Optometry. Ms. Calahan explained the Lieutenant Governor's Executive Order, the role of the Board, and the work performed to date by the Board in rewriting the optometry Act. The discussion was focused on a potential expansion to the scope of practice for optometrists. The Idaho Medical Association and the Idaho Society of Ophthalmology have requested additional information about the training and qualifications of Optometrists to perform laser procedures. A second meeting is scheduled for November 27, 2018.

Ms. Cory provided a very brief overview of the role of the Board and the role of the Association.
