The meeting was called to order at 1:15 PM MDT by Brian White. He welcomed Andrew Mix as the Board's newest member.

NEW BUSINESS

STATUTE/RULE CHANGE & LANGUAGE REVIEW PER NEW IDAHO CODE § 67-2614

Mr. Ellsworth explained the changes that were made during the 2015 Legislature to Idaho Code § 67-2614 regarding licensure renewal and reinstatement.

Mr. Toryanski reviewed proposed changes to Idaho Codes § 54-2214 and 54-2215 to be in accordance with Idaho Code § 67-2614. The Board discussed the changes and the effects on licensure renewal and reinstatement.

Mr. Toryanski also reviewed changes in Rules 200 and 250 to agree with Idaho Code § 67-2614. The Board discussed these changes and how they would affect licensure renewal and reinstatement regarding continuing education.

Mr. White asked about the total number of continuing education hours required if a person's license was lapsed at least three years. He said that if a person is required to complete 16 hours annually, they would need to provide proof of 16 hours of continuing education for each year. Mr. White said this upholds the Board's responsibility of protecting the public. The Board discussed this

requirement at length and agreed with Mr. White. Ms. Cory suggested clarifying language for Rule 250: “Every person holding a license issued by the Board must annually complete sixteen (16) contact hours of continuing education prior to license renewal or sixteen (16) contact hours of continuing education for each year expired prior to reinstatement.”

Ms. Lieppello made a motion to have Idaho Code § 54-2214 be repealed from the Idaho Code and Idaho Code § 54-2215 be accepted as proposed, and have them forwarded to the Division of Financial Management and the Governor’s Office. It was seconded by Mr. Bailey. Motion carried.

Mr. Bailey made a motion to accept Rules 200 as proposed and 250 as revised and proposed and have the Bureau send them to the Governor’s Office for review by the Idaho 2016 Legislature. It was seconded by Mr. Mix. Motion carried.

ADJOURNMENT

Ms. Schroeder made a motion to adjourn the meeting at 2:02 PM. It was seconded by Mr. Bailey. Motion carried.
