The meeting was called to order at 9:30 AM MDT by Brian White.

APPROVAL OF MINUTES

Mr. Mix made a motion to revise page 2 under "Assessments, Discipline/Re-Licensure" to state that the subcommittee was Mr. White and Mr. Mix rather than Mr. Bailey and Mr. Mix, and approve the minutes of 5/12/2017. It was seconded by Mr. Bailey. Motion carried. Mr. Bailey made a motion to approve the minutes of 6/7/2017. It was seconded by Mr. Mix. Motion carried.

LEGISLATIVE REPORT

Ms. Cory gave the legislative report. She reviewed the previous approval of the continuing education rule and notice to licensees discussed at the 2/10/2017 meeting. The deadline to submit proposed legislative ideas to the Governor's Office is July 14, 2017 and the deadline to submit proposed law and rule changes to the Governor's Office is August 18, 2017 for the 2018 Legislative Session.

EXECUTIVE ORDER

Ms. Cory reviewed the Executive Order issued by Acting Governor Little which requires state agencies to submit a report to the Office of the Governor no later than July 1, 2018. The report will assess whether the licensure requirements are

necessary and in the public interest while providing recommendations for improvement, modification or elimination. Ms. Cory said the link for comments regarding the Executive Order is on the Board's website.

FINANCIAL REPORT

Ms. Hall gave the financial report, which indicated that the Board had a cash balance of \$249,687.18 as of 6/30/2017.

CONTRACT RENEWAL

Ms. Hall reviewed the 2018 contract with the Board. Mr. Mix made a motion to approve the 2018 contract and authorize the Chair to sign it. It was seconded by Mr. Bailey. Motion carried.

PHYSIOTHERAPEUTICS AND PHYSIOTHERAPY DISCUSSION

Mr. Ellsworth reviewed the Chiropractic Practice Act in Idaho Code § 54-704(1) with the Board. He said that physiotherapy is within the scope of practice for a Chiropractor practicing in Idaho. Ms. Peel said that the Board has sent warning letters to certain Chiropractors who have advertised the use of “physical therapy” on their website, and these Chiropractors have complied by removing the language.
