She said that the 2016 Legislature passed House Bill 341 that eliminates the requirements for certain health care providers to self-report to the IDACARE database as of July 1, 2016. Consumers will be directed to the Board's website for verified information on licensure status and discipline.

She said that proposed law changes are due to the Governor's Office by August 1, and proposed rule changes are due to the Governor's Office by the third week in August for the 2017 Legislature.
