He said that the proposed rule changes had been approved by both the House and the Senate Committees and the changes will take effect when the 2017 Legislature adjourns. An agenda item based on ensuring that the rule changes do not affect newborn hearing screenings has been added to the To-Do list for the next face-to-face Board meeting.

The bill requiring licensure for Sign Language Interpreters has passed the House with a vote of 43 to 27. It has been referred to the Senate.
