NEW BUSINESS

LAW/RULE CHANGES

Mr. Hales presented the proposed law change for Idaho Code 54-3204(8), which allows communication technology in the practice of social work, including supervision. Mr. Walton made a motion to approve the proposed law change and submit to the Governor's Office. It was seconded by Ms. Kase. Motion carried.

Mr. Hales presented the proposed temporary rule change for Rule 211.01.a, which strikes the words an Idaho and requires at least two (2) years of experience as a licensed clinical social worker to register as a clinical supervisor.

Mr. Walton made a motion to approve the temporary proposed rule change and submit it to the Governor's Office. It was seconded by Ms. Kase. Motion carried.
