NEW BUSINESS

EXECUTIVE SESSION

FINDINGS OF FACT AND CONCLUSIONS OF LAW

Mr. Ellsworth discussed the circumstances regarding cases SWO-2010-20 and SWO-2009. Board Members confirmed that they had reviewed the entire record. Mr. Ellsworth asked the Board to note corrections to the Order on paragraphs I and J. It was moved by Mr. Walton that the Board accept the Hearing Officer's Finding of Fact, Conclusions of Law and Recommendations on cases SWO-

2010-20 and SWO-2009-3 and that a Final Order be prepared. The Board imposed two year probation and required payment of a \$500 fine within 90 days of the Order and payment of the cost and fees within the two year probation period. Respondent must complete 10 hours of ethics continuing education (pre-approved by Board member Mr. Walton) above the required 20 hours of continuing education for the next renewal year and provide continuing education documentation to the Bureau for the next 5 years. The Chair is authorized to sign the Order on behalf of the Board. It was seconded by Ms. Burt. Motion carried.
