Ms. Dickman made a motion that the Bureau contact ASWB on the applicant's behalf requesting the 90 day be waived and let the applicant know that Board cannot accept the clinical level exam in place of passing the masters level exam for the masters level license. Dr. Pepi Downey seconded the motion. Motion carried.
